#### Introduction

In 2013 Restorex produced a report on the external fabric condition of the building. The following year we were appointed to carry out extensive repairs and refurbishment of the external fabrics, involving built up flat roofing, slating, architectural lead work, masonry and decoration.

### Objectives of the project
